1.0 Call to Order: The meeting was called to order at 6:04 pm by Chair Scott Rindenow, followed by the Pledge of Allegiance.

2.0 Introductions: Scott Rindenow asked the MAC Board members to introduce themselves.

5.0 Special Presentation: Emily Leinen from Cal Trans gave an update on several projects in the Rim of the World area. She discussed the current project at Hwy 173 and Hospital Rd. She discussed the progress and the timetable. She shared that Cal Trans will be clearing brush on the center divider of Hwy 18. She discussed the status of the changeable message boards on Highways 18 and 138.

6.0 Community & Government Updates:

- **San Bernardino County Sheriff: San Bernardino County Sheriff:** Lt. Craig Harris shared that the Sheriff's Aviation Unit recently did a nighttime flyover of the mountain communities – particularly along the Hwy 18 and 330 corridors - looking for homeless camps. They did not find any. He reminded people to be careful during holiday shopping and to keep any gifts in their cars out of site. Make sure to lock your car. He also discussed the increase in catalytic converter theft occurring in the mountains and other areas of San Bernardino County.
- **CHP:** Officer Barajas mentioned a recent meeting with Cal Trans regarding coordination of chain control and other winter issues.

- **San Bernardino County Fire:** BC Bryant James discussed fire season preparations and the Toys for Tots toy drive.
- **Cal Fire:** Tony Jones said that they are starting to get a handle on the big fires in the state. He discussed potential Santa Ana wind conditions.
- **USFS:** Brian Grant discussed current resource levels. He also discussed fire restrictions and planned control burns in the Big Bear and Grass Valley Lake areas.
- **Rim of the World Education Foundation:** Mary Justine Lanyon shared that they are currently holding a membership drive. They are also requesting donations on their website.
- **Rim of the World Historical Society:** Marilyn Mayes shared some dates that the museum will be open. They will be holding their annual holiday celebration on December 4th.
- **Rim of the World Unified School District:** Cindy Gardner reported that several fall sports teams are league champions this year. A big issue for the District is the Governor's vaccine mandate. Students must be either vaccinated or tested weekly.
- **Rim of the World Association of Realtors:** Cynthia Carley shared that more sales are to full-timers. The market remains strong.
- **Lake Arrowhead Communities Chamber of Commerce:** Robin Bull discussed two upcoming events: The Blue Jay Parade and the mixer at Jettie's.
- **Lake Arrowhead Community Services District:** Catherine Cerri reported that water use is down 21% compared to the same period last year. They have received a \$2 million dollar grant from Tesla for emergency power for their lift stations. They are also working on two new well projects.
